# Child Health Recognition Awards

### Introduction

Public health professionals deal with childhood health issues: fighting asthma, boosting immunizations, providing better access to dental care, coaching women through healthier pregnancies, combating lead poisoning and confronting obesity with better nutrition and food choices.

This year's North Carolina GlaxoSmithKline Foundation Child Health Recognition Awards program shows how public health professionals embrace and confront new challenges, and how they change with the times.

Our 2017 nominees span the state—representing 25 counties and state government. They highlight new issues such as:

- "Escape the Vapes," an educational campaign that addresses the alarming increase in the use of e-cigarettes among middle and high school students in Cleveland County.
- "Think Before You Ink," which educates Macon County students about the dangers of using tattoo artists operating without proper health permits.
- The JustTEENs Clinic established by the Guilford County Department of Health & Human Services to offer private, confidential, friendly, free or low-cost services for teen health needs. In addition to physicals, immunizations, pregnancy tests and infection screenings, the clinic also offers counseling services.

Since 1994, the North Carolina GlaxoSmithKline Child Health Recognition Awards program has recognized excellence and innovation in child health care, and this year's nominees are carrying on a proud tradition of developing creative, innovative and effective approaches in the field of public health. # Local Health Department Award

The Local Health Department Recognition Award recognizes local health departments that have developed an innovative program producing measurable, sustainable outcomes.

2017 Local Health Department Award Winners:

Gaston County Department of Health & Human Services

### **Substance Treatment And Rehabilitation Program (STAR)**

Gaston, NC 704-853-5139

In the United States, an infant is born with signs of drug withdrawal every hour. The impact of maternal drug use causes a wide range of shortand long-term effects like low birth weight, congenital anomalies and growth and behavioral problems. To combat this, the Gaston County Department of Health & Human Services launched the Substance Treatment and Rehabilitation Program (STAR) in February 2016 to provide drug treatment and supportive counseling to pregnant women. STAR has seen positive outcomes within its first year, not only among the women and children served by the program, but also through the agency's convening of stakeholders and partners around this issue. In addition, other counties in North Carolina are replicating STAR. This program is a shining example of how innovation and collaboration can drive substantial and sustainable change in a community, and make a tremendous difference in the lives of women and their babies.

### **JustTEENS Clinic**

High Point, NC 336-641-3712

Focused specifically on teens, the JustTEENS clinic offers private, confidential, friendly, free or low-cost services set up to support teen needs. In addition to physicals, immunizations, pregnancy tests and infection screenings, the clinic also offers counseling services.



The clinic, using evidence-based practices, reported seeing 926 unduplicated teens in the first year, up from 225 at the Wendover site the prior year. The clinic's success and grant funding allowed a new clinic to open in May 2017 in an area where the highest teen pregnancy rate occurs. The JustTEENS initiative has been so successful because of the diligent work by the public health staff as they offer services where they are needed and in a teen friendly environment.

# Madison County Health Department

### Madison Substance Awareness Coalition Marshall, NC

Like many communities, Madison County has seen an increase in substance abuse among teens and adults ranging from tobacco use to prescription drugs to illegal street drugs. In 2014, the Madison County Health Department used a state grant to form the Madison Substance Awareness Coalition (MSAC). In less than three years, MSAC has successfully implemented both environmental and individual strategies to help raise awareness around substance related issues. By engaging youth through educational classes, assemblies, community events and student led projects, MSAC continues to spread the word about the dangers of prescription medication and other substances impacting the community. The coalition has earned a reputation for taking action to reduce youth substance use and by extension, reaching the adults in the students' lives, as well.

### **AppHealthCare**

**Innovative Approaches Initiative**

Some youth and young adults have special health needs—for instance, autism or trauma often associated with being placed in foster care—that are not easily met by standard public health care services. The Innovative Approaches Initiative at AppHealthCare, supported by the N.C. Division of Public Health, Children & Youth Branch, has helped to create an Inclusive Young Adult Group program, which serves as a social and peer mentor group to young adults ages 16-21 with special health care needs. The initiative is a collaboration that has focused on two grassroots community coalitions. One is the Transition Collaborative, comprised of 22 agency representatives and parents who meet on a monthly basis to strengthen systems of care for children and youth with special health care needs through their transitions to adulthood. The other is the Hub for Autism and Neurodiversity, comprised of 13 stakeholders and parents of children with special health care needs.

### Catamba County Public Health WIC Dental Partnership Program

Many more families in Catawba County now have a true dental home, thanks to a partnership formed in January

2017 between the Catawba County
Women, Infants and Children's (WIC)
program and the Catawba Family Dentistry
(CFD) program. The goal is to increase the
number of women, infants and children
who establish a dental home and receive
regular care. To make the appointment
process easier, a staff person from CFD is
located within the WIC office and serves
as a liaison for families. This collaboration
has increased dental appointments and
decreased no-show rates, and has created
more access to dental care for women,
infants and children in Catawba County.

# Chatham County Public Health Department Child Care Health Consultation Program


For the past three years, this Chatham County program has taken an innovative approach to increasing the rate of children ages 0-5 years who are fully up to date on their required immunizations. These efforts, which include training, tracking, gathering feedback and following up with child care facilities, have increased reporting among child care facilities from 62 percent to 100 percent and children in these facilities who are up to date on immunizations from 25 percent to 96 percent. Chatham also has ranked #1 in the state for the past three years in immunization rates among children ages 0 to 36 months. The increase in immunization rates over the past three years speaks to the effectiveness of the collaborative effort and technical assistance provided by the program, which can be replicated at other health departments.

# Cleveland County Public Health Center Escape the Vapes Program

"Escape the Vapes" is a new way to address the alarming increase in the use of e-cigarettes among middle and high school students in Cleveland County, thanks to a partnership of the Cleveland County Public Health Center, the school system and other community

partners. The educational campaign, developed by a youth council formed of students from each of the county's four high schools, was funded with a grant and aimed at raising awareness about the potential dangers associated with e-cigarette use in both the general adult community as well as the student population. The campaign included a website (EscapeTheVapes. com), social media messages, a billboard, posters and public service announcements. Following implementation of this campaign, Cleveland County saw a significant decrease in the prevalence of e-cigarette use among its youth.



### Cumberland County Health Department Child Health Clinic

The Cumberland County Health Department's Child Health Clinic has demonstrated a unique multi-faceted approach to improving the health of patients and families. The health department follows the American Academy of Pediatrics' "Bright Futures" guidelines that address prevention and health promotion for infants, children, adolescents and their families. This is achieved through partnerships with community groups that prioritize education and preventative medicine. During physical examinations in the clinic, staff members care for sick children while also focusing on three major areas of mental health, nutrition and tobacco cessation.

### Forsyth County Health Department BeHealthy School Kids

BeHealthy School Kids (BSK) is a comprehensive nutrition education program that promotes physical activity for pre-schoolers through 5th grade students in the public school system. Using a science-based curriculum called "OrganWise Guys" and USDA's MyPlate, students were taught how to be healthy from the inside out by bringing the body to life through fun organ characters and colorful posters about fruits and vegetables. BSK reaches about 7,200 students. With results of about a 62-percent increase of knowledge among kindergarteners at one school and similar success rates at the remaining schools, BSK is making strides against obesity in Forsyth County.



# Graham County Department of Public Health

**Child Health Program**

Asthma is one of the most chronic diseases in children and has proven to be a leading cause of children missing school in Graham County. The Graham County Department of Public Health Child Health Program is coordinating and implementing the Asthma Coalition for Graham County. The coalition includes a partnership of health department staff, school nurses, parents, a mid-level provider and Regional Asthma Disease Management staff. In its first year, the coalition has touched the lives of many children, improving their health and contributing to better attendance and success in school.

Families First Greene County is a collaborative community-based program that coordinates resources for children across multiple agencies. Greene County Health Department formed this collaborative to improve the health outcomes of young children and pregnant women because healthy children lead to healthy families. Many safety tips are provided on a wide range of issues, including fireworks, infant cribs, car seats, bicycle helmets, medication, heatstroke prevention, as well as general safety practices in the home, around the neighborhood and at school. Program efforts include media outreach, enhanced clinical services, distribution of infant formula, safety seats and child backpacks to promote healthy habits and environments for children.

Guilford County Department of Health & Human Services

**Project Access Dental**

In Guilford County, as in many counties across the state, staff encounter children who have no insurance, no Medicaid and no money to pay for dental care. Many have never been to a dentist, and endure pain and infection from decayed teeth. Some suffer malnutrition because they can't properly chew. Project Access Dental (PAD) is a grant-funded program of the School Health Unit, created to help children in need of dental care treatment. Any public school student who has a restorative dental need, is not insured and whose family



is unable to pay for care is eligible to apply for PAD funds. Children of families who apply and qualify for PAD receive dental care in health department dental clinics.

Henderson County Department of Public Health

**Henderson County Immunization Coalition** Hendersonville, NC 828-692-4223

The Henderson County Immunization Coalition was formed in 2014 in response to declining immunization rates and increasing diseases that can be prevented with vaccines. As a grassroots effort, the organization's mission has been to promote a partnership within pediatric and family practices by eliminating barriers, sharing resources and collaborating to stop the spread of vaccine preventable disease. The group organizers have written newsletters and organized presentations to physician groups, child care providers and civic organizations. It also has organized promotional efforts for National Infant Immunization Week. These efforts have paid off—Henderson County now has some of the highest immunization rates seen in over a decade.

Henderson County Department of Public Health

**Youth Tobacco Prevention Advocacy Project** Hendersonville, NC 828-692-4223

Here's one way to educate youth about the dangers of tobacco use: Involve them in a project to collect data and then persuade the Board of Health to pass a resolution requesting policy change at the state level! That's what happened in Henderson County, where the Health Department created a unique collaboration to collect and evaluate information about how retailers and the tobacco industry market nicotine products to youth. Students conducted store audits to document and assess tobacco advertisements and placement of tobacco products, especially popular products like e-cigarettes. Students assisted health department staff in presenting their findings to the Board of Health and School Student Health Advisory Council (SHAC) and asked for support for repealing state tobacco preemption rules. The Board of Health signed a resolution and SHAC provided a letter of support, which were forwarded to advocates at the state level.

Henderson County Department of Public Health

**WIC Program**

Obesity and lack of nutrition from food insecurity are both threats to healthy mental and physical development in children. Through the strengthening and expansion of partnerships, the Henderson County Women, Infants and Children's (WIC) program office has implemented a three-pronged food assistance and nutrition education program through hands-on education. Several community gardens have been established at schools, child care centers and housing developments with the use of grants, interns and volunteers. One garden is at the WIC clinic, which helps staff provide hands-on gardening education, healthy recipes and samples, and fresh fruits and vegetables during WIC appointments, serving more than 2,100 families annually. The ultimate goal is to grow children with fewer health problems while decreasing their risk of becoming obese as they are taught about healthy eating habits.

### Macon County Public Health

### **Think Before You Ink Program**

In April 2016, Jennifer Garrett, Macon County Public Health's director of nursing, learned that a student was tattooing fellow students in his bedroom. Concerned about hygienic practices and the potential for blood borne pathogen exposure, she and colleague Jonathan Fouts, an environmental health specialist, worked with state health officials to offer free hepatitis B and C and HIV testing to individuals who had been tattooed by this tattoo artist operating without a permit. Taking this a step further, they developed and launched a program called "Think Before You Ink," aimed at educating Macon County students about the dangers of unpermitted body art. Their work has led to proposed legislation that will protect the health of North Carolina children and could potentially save lives.

### Mecklenburg County Public Health

#### **Pediatric Dental Clinic**

In Mecklenburg, an urban county of more than 1 million, a crescent-shaped area of poverty and low educational attainment exists around the center city of Charlotte. Compared to other areas of the county, residents who live in these areas tend to have higher rates of chronic disease and death. Mecklenburg County Public Health has targeted these public health priority areas for improvements in health behaviors and health outcomes. In 2015, one priority was to increase tobacco cessation interventions—specifically those impacting children—in targeted health department clinics. The first focus was the Pediatric Dental Clinic, which serves children 17 years and younger, and has 7,000 client visits per year. The second focus is the Women, Infants and Children's Clinic, which is the largest WIC program in the state with 22,000 annual client visits. Both clinic efforts encourage and empower parents who use tobacco to cut back or quit, resulting in healthier home environments for children through reduced exposure to secondhand smoke, reduced triggers for asthma, improved parental health and tobacco-free role modeling to youth.

### New Hanover County Health Department

### **Parent Intervention Training**

For parents of young children with emotional and behavioral problems, just getting a child to school without tears can be a tremendous challenge. Sometimes, the children become physically violent. The New Hanover County Health Department is providing a treatment that is making a true difference in the lives of these families and children. The department offers a program called Parent-Child Interaction Therapy (PCIT), a parent training intervention that teaches caregivers specific behavior management techniques for use with children. Parents have reported high satisfaction, including one who noted that her daughter is "doing great this school year. We have not had one single day of crying this school year when she's dropped off, unlike last year, when she cried every single day." Another parent called PCIT "an invaluable tool in my toolbox."

### Toe River Health District

### **Mitchell Yancey Healthy Families**

The Toe River Health District (TRHD) actively led the community in implementing Mitchell Yancey Healthy Families, an evidence-based intensive home visiting program designed to meet the specific needs of families and young children. The program targets overburdened families at risk for child abuse and neglect, and is designed to work with families who may have histories of trauma, intimate partner violence, mental health concerns and/or substance abuse issues. The program supports families and children in seeking well-child or prenatal care, establishing a medical home, following prescribed well-child and immunization schedules, and seeking income maintenance support programs, nutrition and physical activity education, housing and transportation. This creative, collaborative effort strengthens parent-child relationships, and promotes overall healthy childhood growth and development.

## Public Health Staff Award & Nominees

Her efforts have helped keep local providers updated on upcoming immunization educational opportunities and vaccine recommendations, and have provided resources including immunization tracking tools and incentive programs.

Doris Hogan pours her heart and soul into the Childhood Lead Poisoning Prevention Program of Forsyth County, working hard every day and also on Saturdays as needed to make sure that all children affected by lead are surrounded with the resources to lower their lead levels and counter any damage lead may have already caused. She has completed or assisted in hundreds of investigations, and has worked tirelessly to educate businesses, homeowners, families and the court system about the damage lead poisoning causes. Doris has created the CLPPP webpage and brochures, handouts, display boards and posters that educate the public on the risks of lead hazards in the community. She also makes sure CLPPP is actively talking to doctor's offices, hospital systems and other organizations to ensure that they are up-to-date on all current lead rules, testing requirements and processes. She is improving the health outcomes of children and their families in Forsyth County.

Christy Klaus is a tireless and compassionate champion for children's environmental health. She performs her investigations of homes of young children with elevated blood lead levels with meticulous detail. She advises families on healthy homes best practices and works hard to find the source of a child's lead exposure. She educates parents using straightforward, simple language and humor. She has performed detective work in finding new sources of non-paint lead exposures such as spices, ceremonial powders, herbal remedies and artificial turf, and has contacted federal authorities to alert them to the need to better screen these consumer items for lead. She has elevated awareness of the lead exposure risk that imported spices can pose to families and young children who regularly include spices in meal preparation. Christy demonstrates a true passion for protecting children's health.
